#### 1.0 SCOPE AND APPLICATION

This standard operating procedure (SOP) provides information relating to the Automated External Defibrillator (AED) program. Individuals trained in the use of an AED shall refer to these procedures and additional information provided in the Lewis Energy Group (LEG) Emergency Response Plan (ERP). All LEG Business Units (BU) are subject to this SOP.

#### 2.0 TRAINING

- Perform training in Cardiopulmonary Resuscitation (CPR) and AED according to the Medic First Aid guidelines.
- Repeat CPR and AED training every two years.
- Maintain training records in the LEG Safety Office.

#### 3.0 AED LOCATIONS

AEDs are installed at the locations listed below:

AED LOCATION
Sage Yard – Security Guard Station
Encinal Admin Building
Encinal Safety Building
Rigs (Toolpusher / Safety Trailer)
Sabino Frac Sites (Datavan)
LEG San Antonio 7 <sup>th</sup> Floor Office (Mailroom)

#### 4.0 PROCEDURES

#### 4.1 Maintain Preparedness

- Review the AED locations noted in Section 3.0 of this SOP.
- Maintain and test the AED according to manufacturer specifications.
- Keep documentation of maintenance and testing for a period of at least five years. Documentation
  must include the date, the type of maintenance/testing performed, and the signature of the person
  who performed said maintenance/testing.

#### 4.2 Provide Aid to Victim

If the victim is unresponsive, adhere to the following guidelines:

- CALL "9-1-1" immediately. Appoint an individual to direct Emergency Medical Services (EMS) upon arrival. Bring the AED to the location of the victim.
- Assess the victim (airway, breathing, circulation).

- If required, initiate CPR.
- Turn on the AED and stop CPR while the AED analyzes the heart rhythm.
- Bare and prepare the victims chest for AED use.
- Place AED electrode pads on the victim as illustrated. \*\*Electrode pads may only be used once.
- Follow AED prompts for additional action. If the AED prompt indicates the victim requires a "shock", do so after clearing personnel from the victim area.
- Upon arrival of EMS, if known, provide the victim name, age, medical problems, incident time, and number of shocks administered.
